Subject: ADEK CIRCULAR: GRADUAL RESUMPTION OF FACE-TO-FACE
LEARNING

Dear Parents and Guardians,

Greetings from PEPS.

In line with recent guidance from the relevant education authorities, schools are required to **reopen for face-to-face learning starting Monday, April 20**, following ADEK approval. Schools may implement a **gradual and staggered return**, depending on operational feasibility and readiness.

For PEPS, we would like to inform you of the following arrangements

1. NOC Status and Learning Mode

- The school is currently awaiting the **No Objection Certificate (NOC)** approval.
- We will wait for the final NOC until **Sunday at 5:00 PM**.
- If the NOC is received, we will proceed with **face-to-face learning starting Monday, April 20**
- If the NOC is **not received by Sunday 5:00 PM**, classes on Monday will continue **online (distance learning mode)**.

Note: We will announce immediately whatever be the mode of learning on Monday.

2. School Bus Services

- At this stage, **no official government decision has been issued regarding the resumption of school bus services**.
- Parents are kindly requested to make necessary arrangements for student transportation if face-to-face learning resumes.
- We kindly ask for your **understanding, flexibility, and support**, especially for students who may experience difficulty attending on time or physically reporting to school.

3. Safety Protocol

- The safety and well-being of our students remain our highest priority.
- Please refer to the **attached Safety Protocol for the Safe Resumption of Onsite Learning**, which outlines all required procedures to ensure a safe school environment.
